

**ROYAL SHINE CAR WASH
CORVETTE STINGRAY SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN
A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING
VOID WHERE PROHIBITED BY LAW**

- 1. Entry Period.** This Corvette Stingray Sweepstakes (the "Sweepstakes") begins on April 1, 2021 and ends on May 31, 2022 ("Sweepstakes Period").
- 2. Eligibility.** The Sweepstakes is open only to legal residents of Missouri and Kansas entering the Sweepstakes from within Missouri or Kansas, who are 18 years of age or older as of the date of entry. The Sweepstakes is sponsored by the Royal Shine Car Wash ("Sponsor"), located at 13621 W. 63rd Street, Shawnee, Kansas 66216. Employees, officers and directors of Sponsor along with its affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies, (collectively, "Sweepstakes Parties") their immediate families (parent, child, sibling & spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Sweepstakes. By participating, you unconditionally agree to and accept these Official Rules and the decisions of the Sponsor, which are final and binding in all respects. In addition, to be eligible to win and collect the prize, you must provide proof of insurance for the winning car, and you must also execute and return Sponsor's forms for you to: (i) consent to the use of your rights of publicity, (ii) assume all tax liabilities, (iii) waive all claims against Sponsor and Promotional Parties, and (iv) confirm your eligibility (collectively "Affidavits and Waivers"). This Sweepstakes is void in any state not listed above and where prohibited by law, rule or regulation.
- 3. How to Enter.**
 - a. Free Entry at the Time of Purchase.** *To enter this contest at the time of purchase, you may purchase a car wash membership from Sponsor during the Sweepstakes Period. Your entry will be automatic and Sponsor will collect your full name, e-mail address, street address, city, state, ZIP Code, daytime telephone number, date of birth (MM/DD/YYYY), and driver's license number. You are not required to enter the Sweepstakes at the time of purchase.*
 - b. Free Method of Entry Without Purchase.** *To enter this contest without purchase, an eligible entrant may mail in a postcard to enter. The eligible entrant may hand-write his/her full name, e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP Code, daytime telephone number, date of birth (MM/DD/YYYY), and driver's license number on a post card acceptable to the US Postal Service ("Mail-In Entry") and mail it with sufficient postage to: 13621 W. 63rd Street, Shawnee, KS 66216. A Mail-In Entry must be postmarked by May 20, 2022 and received by May 31, 2022 to be eligible.*
 - c. Incomplete Entries and Entries with Errors.** Entries that are incomplete, corrupted, false, lost, late, misdirected, deceptive, or are otherwise not in compliance with these Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. In the event of a dispute regarding the identity of the individual who submitted an entry cannot be resolved to the Sponsor's satisfaction, the affected entry will be deemed ineligible. **LIMIT ONE ENTRY PER HOUSEHOLD.** Any person who attempts to or otherwise encourages the entry of multiple or false information under multiple households, as determined by Sponsor, will be disqualified.
- 4. Prize.** The prize to be awarded during the Sweepstakes is a 1974 Corvette Stingray. The prize is in no way funded or comprised of purchases that may be related to the Sweepstakes. The prices of car wash plans have not been changed as a result of the Sponsor offering this

Sweepstakes. Any costs associated with registration and licensing of the car are the sole responsibility of the winner. All other costs, expenses, and taxes associated with the prize acceptance, whether or not mentioned herein, are the sole responsibility of the winner. All portions of the prize are non-assignable and non-transferable.

5. **Prize Restrictions.** The prize will be awarded at Royal Shine Car Wash, located at 13621 W. 63rd Street, Shawnee, Kansas 66216. Prior to taking possession of the prize, the winner will be required to show proof of insurance for the car before taking ownership of the car and shall be responsible for any taxes, fee, and costs customary with obtaining a car. The winner of the prize will also be subject to any additional terms as set forth by the Sponsor. If the selected winner cannot produce valid proof of insurance for the car within fifteen (fifteen) days of the end after receiving notification by Sponsor, winner will be deemed for forfeit the prize and a different winner will be selected. If a potential winner fails or refuses to sign and return Affidavits and Waivers the winner may be disqualified and an alternate winner may be selected.
6. **Drawing and Odds.** On or around June, 2022, one (1) potential winner will be randomly selected in a drawing from all eligible entries received during the Sweepstakes Period by the Sponsor. The winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules. The odds of winning depends upon the total number of eligible entries received.
7. **Notification.** The potential winner shall be notified by the contact information he/she provided to Sponsor. Potential winners will have twenty-four hours after receipt of such notice to claim their prize and complete all additional Affidavits and Waivers. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept the prize or, if Sponsor or its authorized designee is unable to contact the potential winner, the prize may be forfeited, and in the Sponsor's sole discretion, the prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion.
8. **Rights of Publicity.** By entering this Sweepstakes, you consent to Sponsor's use of your name, voice, signature, photograph and likeness ("Persona") for the purpose of promoting Sponsor's business and its services, and for other commercial uses deemed reasonable in Sponsor's sole discretion. Such consent includes your consent to permit Sponsor to allow third parties to assist or provide such promotional uses on Sponsor's behalf. By entering this Sweepstakes you hereby agree that your entry and ascent to these Official Rules shall act as a written consent of all such commercial uses of your Persona. Additionally, by entering this contest you acknowledge understand, consent, and agree that tax information and other information may be provided to governmental and taxing authorities.
9. **Conduct.** By participating in this Sweepstakes, you agree to be bound by these Official Rules and the decisions of the Sponsor and the Sweepstakes Parties, which shall be final, binding and non-appealable in all respects. Failure to comply with these Official Rules may result in disqualification. The Sponsor reserves the right at its sole discretion to disqualify any entries from any individual found to be tampering with the participation process, interfering with the operation of the Sweepstakes, or to be acting in any manner deemed by the Sponsor to be in violation of these Official Rules, or to be acting in any manner deemed by the Sponsor to be un-sportsman like or disruptive, or with intent to annoy, abuse, threaten or harass any other person. CAUTION: ANY ATTEMPT BY A USER, YOU OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES A VIOLATION OF CRIMINAL AND CIVIL LAWS, AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.
10. **Liability Limitations.** The Sponsor assumes no responsibility or liability for (a) lost, late,

stolen, undelivered, inaccurate, incomplete, delayed, misdirected, or damaged entries; (b) any incorrect or inaccurate entry information; (c) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (d) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, cable, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes. If, for any reason, the Sweepstakes (or any part thereof) is not capable of running as planned for reasons including, without limitation, acts of God, accident, riots, war, terrorist act, epidemic, pandemic, quarantine, civil commotion, breakdown of communication facilities, natural catastrophes, governmental acts or omissions, changes in laws or regulations, national strikes, fire, or explosion, then the Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes in whole or in part.

- 11. Releases.** All participants, as a condition of participation in this Sweepstakes, agree to release, hold harmless, indemnify and defend the Sponsor, its officers, directors, accountants, attorneys and agents ("Released Parties") from and against any and all liability, claims, damages, or actions of any kind whatsoever for injuries, damages, or losses to persons or property which may be sustained, in whole or in part, directly or indirectly, in connection with (i) participation in any aspect of the Sweepstakes, (ii) the receipt, ownership or use of the prize awarded, or (iv) any typographical or other error in these Official Rules. All participants further agree that in any cause of action, the Released Parties' liability will be limited to the cost of participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. All participants waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.
- 12. No Warranties.** NEITHER SPONSOR NOR ANY OF THE RELEASED PARTIES HAVE MADE OR MAKE OR ARE RESPONSIBLE OR LIABLE FOR ANY WARRANTY, REPRESENTATION OR GUARANTEE, EXPRESS OR IMPLIED, RELATIVE TO THIS SWEEPSTAKES OR THE PRIZE, INCLUDING BUT NOT LIMITED TO, ITS QUALITY OR FITNESS OR MERCHANTABILITY, AND THE PRIZE TENDERED TO ENTRANTS ON AN "AS IS" BASIS. THERE ARE NO WARRANTIES REGARDING THE PRIZE.
- 13. Disputes and Choice of Law.** Except where prohibited by applicable statutes, all issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrants or winners, Sponsor, and administrator in connection with this Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Kansas, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of Kansas or any other jurisdiction), which might otherwise cause the application of the laws of any jurisdiction other than the State of Kansas. Any action seeking legal or equitable relief arising out of or relating to the Sweepstakes or these Official Rules shall be exclusively brought in the state courts of the State of Kansas sitting in Johnson County, Kansas. You hereby irrevocably consent to the personal jurisdiction of said courts and waive any claim of forum non-convenience or lack of personal jurisdiction they may have.
- 14. Taxes.** All federal, state, local, and other taxes on the prize and any other costs and expenses associated with prize acceptance and use are the sole responsibility of the winner. A 1099 tax form (preceded by a W9 Form) will be issued to the winner who receives the prize equal to or exceeding IRS reporting requirement thresholds.
- 15. Other Fees and Registration Costs.** The winner will solely be responsible for all transfer fees, registration fees, state sales tax, local tax, document fees, licensing costs, title fees and other fees, costs and taxes customarily associated with the purchase of a car shall be the sole responsibility of the prize winner.
